





Communities of Color were Hit Hardest in the Recession






Slower and Unequal Growth


Polarizing Economic Structure: Job Growth by Wage Levels, 1990-2010


Addressing Education Disparities will be Critical to Grow A Strong and Skilled Workforce
















Changing U.S. Demographics, 1970-2050


The Demographics of Seniors and Youth are Diverging

Percent People of Color Among Senior and Youth Populations, 2010























- Less than 25%






